5. ACTION ITEMS

a. Department Presentation - Early Childhood Education Program - Dr. Alex Elliott

Minutes

Chris Reed announced that we are celebrating 60 years of Head Start and welcomed Dr. Alex Elliott to present on the Early Childhood Education program. Dr. Elliott explained that Early Childhood Education (ECE) Program serves the youngest children and their families in Tulare County. For 2025-2026, the program has a budget of \$88.4 million, manages 23 grants, and has 419 positions. They assist new child care providers open new facilities. Last year, they assisted 71 providers. ECE operates 19 preschools. The 19th preschool opened two weeks ago in partnership with Woodville Union School District. Village Preschool is currently in the process of being licensed to TCOE. ECE serves up to 800 children in the 19 preschools and operate six kitchens. A new centralized kitchen is being built in Visalia, which is expected to be complete January 2026. ECE serves 410 children in their Home Base program.

Their funding sources are CASPP (from the State of California), Head Start, and Alternative Payment Programs. Dr. Elliott explained that Head Start funding release on May 2 and it is not scheduled to be cut at this time. The Alternative Payment Programs helps enroll families and providers. It serves 4,436 children attending around 1,200 provider programs. Dr. Elliott provided a folder for each board member with more program information.

Chris Reed explained that the Superintendent is the Board of One and takes action on items for Head Start. Dr. Elliott added that the Parent Policy Council serves as a board and review the items before they are submitted to the Board of One. Celia Maldonado-Arroyo requested that the Board receive information on how students are progressing in the Head Start Program.

b. Presentation on Cyberbullying - Kai Bolden

Minutes

Kai Bolden, a civics and economics teacher at Mt. Whtiney High School explained that student are assigned a civic engagement project. These three students chose cyberbullying as their topic. Timonthy Florez, Drew Banuelos, and Skylar Padgett introduced themselves and thanked the Board for the opportunity to present. They want to teach a younger audience about the effects of cyberbullying, especially about how it can cause serious emotional distress leading to anxiety, depression, and even suicidal thoughts. They also want to teach them about digital citizenship which is responsible, respectful use of technology, and help them understand how to navigate digital environments safely and ethically. They presented their presentation to the Board and explained that the target audience is sixth-graders. They used links to stompout.org, a non-profit organization with no fee for access to resources for parents and students.

The Board thanked them for their presentation and commended them for their choice of topics.

10. Public Hearing for Local Control and Accountability Plan (LCAP) for Tulare County Office of Education, Special Services - Kevin Jessee

Minutes

Chris Reed opened a public hearing at 3:38 p.m. Kevin Jessee presented the Tulare County Office of Education LCAP for Tulare County Court School, Community School and Special Education School (AcCEL Program). He reported that in English language arts, scores increased by 31 points and math scores jumped 90.4 points. The graduation rate improved by 15% over last year. In the area of chronic absenteeism, there was a decrease of 3% and there was a reduction of suspension rates. The Board congratulated Mr. Jessee and the Special Services department on their successes. Ms. Reed closed the public hearing at 3:41 p.m.

11. Public Hearing for Local Control and Accountability Plan (LCAP) for University Preparatory High School (UPHS) - Dr. Helen Feller

Minutes

Chris Reed opened a public hearing at 3:41 p.m. Dr. Helen Feller presented the University Preparatory High School (UPHS) LCAP. She shared some highlights including 93.7% of students from the class of 2024 completed the required A through G classes for the UC and CSUs, which is a 5% increase. Additionally, 70% of students reported having access to mental health services, which is an increase of 20%. Attendance rates increased from 90% to 96.4%. The Board congratulated Dr. Feller. Ms. Reed closed the public hearing at 3:48 p.m.

12. Public Hearing for Local Control and Accountability Plan (LCAP) for La Sierra Military Academy - Dr. Jose Bedolla

Minutes

Chris Reed opened a public hearing at 3:48 p.m. Dr. Bedolla presented the La Sierra Military Academy LCAP. He reported the school has had significant growth across every national reporting metric for the state, from improvements in ELA, math, reductions in suspensions, increases in college and career readiness. One area that they are looking forward to expanding next school year is the California College Guidance Initiative, (CCGI). They are using compassionate systems school-side to break through barriers. The Board congratulated Dr. Bedolla. Ms. Reed closed the public hearing at 3:52 p.m.

13. Presentation of the 2025-2026 Proposed Budget for TCOE - Jody Arriaga

Minutes

Jody Arriaga presented the 2025-2026 Proposed Budget. She reviewed the budget assumptions and recent changes. She reported the CSSF revenues of \$242,468,647 and expenditures of \$234,779,526. The estimated ending fund balance is \$120,256,527.51. She reviewed La Sierra enrollment, revenues, and expenses. The La Sierra Charter estimated ending fund balance is \$38,729.16. Ms. Arriaga reviewed UPHS enrollment, revenues, and expenses. The UPHS estimated ending fund balance is \$675,139.79. She reviewed the Early Childhood Education revenues and expenses. The ending fund balance for Early Childhood Education is \$5,603,073.05. She reported the components of the Early Childhood Education fund. Ms. Arriaga review other funds including SCICON Cafeteria, La Sierra Cafeteria, UPHS Cafeteria, Special Education Pass Through, Forest Reserve Funds, and Levis Trust. Finally, she reported total revenue of all government funds. Jody advised that our budget is well within the range accepted by the state. Jody thanked Mr. Hire and the Board for their support.

The Board thanked Ms. Arriaga for her report.

Ms. Reed opened a public hearing at 4:10 p.m. for the 2025-2026 Proposed Budget for TCOE. Dr. Marroquin thanked Jody Arriaga and her staff for all their hard work. We are scheduled to adopt the 2025-2026 Budget for TCOE at the June 4 board meeting. The hearing was closed at 4:11 p.m.

The goals are to provide affordable housing to attract quality educators and provide housing for our staff to have a track to home ownership and long-term security.

Ruben Macareno reported that he enjoyed Slick Rock. He also recently attended a training with CSBA in Sacramento, which was a great learning experience, and a STEM conference.
