FIRST READING, BOARD POLICY AND ADMINISTRATIVE REGULATION 6171 – TITLE I PROGRAMS	Gabriela Guzman presented the first reading of Board Policy and Administrative Regulation 6171 – Title I Programs. This is a mandated policy for school districts and county offices of education that receive Title I funds to ensure comparability of services. This existing policy is being updated and revised according to legal requirements, which will include the AR 6171. This was only an informational agenda item.
BUDGET REVISIONS THROUGH JANUARY 31, 2023	Jody Arriaga presented to the Board the actual expenditures for budget revisions through January 31, 2023. The County School Service Fund showed an increase of more than \$2,305,794 in LCFF. There was a combined increase in the Federal Revenue for CFNL (\$450,000); School Based Mental Health for (\$1,495,829) and Comprehensive School Improvement (\$330,181). State revenues reported a net decrease for the following: After School Education and Safety (\$201,543), ProYouth/HEART (\$313,123), and Teacher Residency Grant (\$250,000). There were also increases in Local Revenue in the following programs: LCFF SPED County Operated ADA, Mental Health Medi-Cal, and CFNL CalHOPE. This showed an estimated ending fund balance for CSSF of \$71,725,573. The Child Development Fund showed an estimated ending fund balance of \$2,482,650.
	It was moved by Reed, seconded by Rodriguez to approve the Budget Revisions through January 31, 2023. Motion carried with the following votes: Ayes:

Coble, Enea, Holguin, Link, Maldonado-Arroyo, Reed, and Rodriguez.

2nd INTERIM REPORT AS OF JANUARY 31, 2023

Jody Arriaga explained to the Board that county superintendents are required to certify twice a year regarding their ability to meet their financial obligations for the remainder of the fiscal year and for the subsequent two fiscal years with adequate reserves. She went on to discuss the Criteria and Standards Review Summary providing an explanation on areas that did not meet the criteria and standards. Mrs. Arriaga reported a positive cash flow for the next two years and the ability to meet fiscal obligations. It was moved by Enea, seconded by Maldonado-Arroyo to approve the Second Interim Report as of January 31, 2023. Motion carried with the following votes: Ayes: Coble, Enea, Holguin, Link, Maldonado-Arroyo, Reed, and Rodriguez.

ADOPTION OF RESOLUTION 22/23-18 SUPPORT OF FUNDING FOR COUNTY OFFICE OF EDUCATION OPERATED JUVENILE COURT AND COMMUNITY SCHOOLS Tim Hire requested the Board's approval to adopt Resolution No. 22/23-18 to support fiscal resources for the provision of public education and college and career transition for youth enrolled in juvenile court and community schools by establishing a formula that supports academic, college and career readiness, and social-emotional services. It was moved by Enea, seconded by Maldonado-Arroyo to adopt Resolution No. 22/23-18. Motion carried with the following votes: Ayes: Coble, Enea, Holguin, Link, Maldonado-Arroyo, Reed, and Rodriguez.

CALL FOR VOTE FOR 2023 CSBA ASSEMBLY COUNTY DELEGATE FOR SUBREGION 12A Jeff Ramsay sought the Board to adopt Resolution No. 22/23-16 which would authorize TCOE to submit a loan application for energy efficiency (\$5 million) for TCOE, 6200 S. Mooney Blvd., Visalia, CA. Jeff said they will install solar panels in back of the building and in the far north parking lot. The funding will also assist in installing additional vehicle (green) chargers. It was moved by Maldonado-Arroyo, seconded by Holguin to adopt Resolution No. 22/23-16. Motion carried with the following votes: Ayes: Coble, Enea, Holguin, Link, Maldonado-Arroyo, Reed, and Rodriguez.

Jeff Ramsay sought the Board to adopt Resolution No. 22/23-17 which would authorize TCOE to submit a loan application for energy efficiency (\$3 million) for SCICON, 41569 Bear Creek Rd., Springville, CA. It was moved by Enea, seconded by Rodriguez to adopt Resolution No. 22/23-17. Motion carried with the following votes: Ayes: Coble, Enea, Holguin, Link, Maldonado-Arroyo, Reed, and Rodriguez.

Tom Link presented to the Board three names that were seeking election for CSBA Assembly County Delegate for SubRegion 12A: Felipe Martinez (Porterville USD), Cathy Mederos (Tulare Joint Union HSD), and Randy Villegas (Visalia USD). CSBA directions were to vote for two candidates. After votes were cast, Felipe Martinez and Cathy Mederos were selected as the two candidates to fill the two seats in Tulare County.

SUPERINTENDENT'S REPORT	Superintendent Hire reported that the Tulare County Spelling Bee will be held here at the Redwood Conference Center. The Poetry & Prose event will be coming up in a couple of weeks welcoming over 1,400 students. Another exciting student event, Career EXPO will be at COS on April 14. Exeter Union High School will compete at the state Mock Trial competition. March 23 will be the 50 th Math Super Bowl competition at Visalia Convention Center. We now own property in Porterville for our Mental Health services. The building used to be a morgue. We are in the process of purchasing 30 acres south of the Liberty Center, with a 60-day contingency on soil tests results. Tim said that he is thinking about this year's budget including budgets for the next couple years. We could be facing some trying financial times. This property will allow us the luxury of time of what we need now or how we could build in phases. We may need to increase prices on services we offer; however, we should not have to cut any services. Mr. Hire went on to remind the Board that we are leasing the back of the Milan building for \$15,000 a month right now for ActVnet staff. Chris asked if we are bringing in money. Mr. Hire said Devon Mathis has written a bill that describes
	the ActVnet program which he hopes to get folks to help sponsor the bill. Language called for any school of more than 100 ADA will have to have this in place by 2030. The state department of public instruction will pay for it. We can only recoup our costs. We can't make money off of this program. Based on what we would charge for all schools in CA, over a 4-year period, there would be about a \$4 billion dollar cushion.

Board Policy

Instruction BP 6171 Title I Programs

Title I Programs

The Tulare County Board of Education (county board) desires to provide a high-quality education that enables all students to meet challenging state academic standards. In schools with a large number or percentage of economically disadvantaged families, the Tulare County Office of Education (TCOE) shall use Title I funds to provide services that strengthen the academic program and provide support to students at risk of failing to achieve academic standards.

Title I funds shall be used to supplement, not supplant, funds available from state and local sources for the education of students participating in Title I programs. (20 USC 6314, 6321)

Descriptions of how TCOE will address the required components of the Title I local educational agency plan, as specified in 20 USC 6312, shall be included within TCOE's control and accountability plan (LCAP), the LCAP Federal Addendum, or another document. School-level strategies shall be aligned with TCOE's plan and be tailored to the specific needs of the students at the school.

In addition, TCOE and each school receiving Title I funds shall develop a written parent/guardian and family engagement policy in accordance with 20 USC 6318.

Comparability of Services

In schools receiving Title I funds, state and local funds shall be used to provide services that, taken as a whole, are at least comparable to services in schools that are not receiving Title I funds or, if all TCOE schools are receiving Title I funds, that are substantially comparable in each school. Comparability may be determined on a school-by-school basis or by grade span. (20 USC 6321)

To demonstrate comparability of services among TCOE schools, TCOE shall:

- 1. Adopt and implement a TCOE-wide salary schedule.
- 2. Ensure equivalence in teachers, administrators, and other staff, as measured by either or both of the following:
 - a. The ratio of students to instructional staff at each Title I school within a grade span, which shall not exceed 110 percent of the average ratio for all non-Title I TCOE schools within that grade span.
 - b. Salary expenditures for instructional staff at each Title I school, which shall be no less than 90 percent of the average salary expenditure across non-Title I TCOE schools.

- 3. Ensure equivalence in the provision of curriculum materials and instructional supplies, by determining whether the per-student expenditure of state and local funds for curriculum materials and instruction supplies in Title I schools is between 90 and 110 percent of the TCOE-wide average.
- 4. Determine whether the amount of state and local funds allocated per student for each grade span is between 90 to 110 percent of the per student average for each grade span in non-Title I schools.

In determining comparability, TCOE shall not include staff salary differentials for years of employment. TCOE also may exclude unpredictable changes in student enrollment or personnel assignments that occur after the beginning of the school year, state and local funds expended for language instruction educational programs, state and local funds expended for the excess costs of providing services to students with disabilities, and supplemental state or local funds expended in any school attendance area or school for programs that specifically meet the intent and purposes of Title I. (20 USC 6321)

The Tulare County Superintendent of Schools (county superintendent) or designee shall annually assess comparability in accordance with the above criteria and maintain records documenting TCOE's compliance. If any instances of noncomparability are identified, the county superintendent or designee shall promptly implement adjustments as needed to ensure comparability.

Program Evaluation

The county board shall regularly monitor the progress of economically disadvantaged and low-achieving students in Title I schools. During the annual evaluation of TCOE's progress toward achieving each goal identified in the LCAP or other planning document addressing 20 USC 6312, the county board shall review disaggregated data on academic achievement, school attendance, and other outcomes for such students and shall ensure that strategies are revised as necessary to support continuous improvement.

School-level strategies shall be aligned with TCOE's plan and be tailored to the specific needs of the students at the school.

In addition, TCOE The county office and each school receiving Title I funds shall develop a written parent/guardian and family involvement engagement policy in accordance with 20 USC 6318.

Local Educational Agency Plan

The county superintendent or designee shall consult with teachers, principals, administrators, other appropriate county office personnel, and parents/guardians of participating students in the development, periodic review, and, as necessary, the revision of a local educational agency (LEA) plan. The plan and any revisions shall be submitted to the county board of education for approval. (20 USC 6312)

The plan shall address the components specified in 20 USC 6312, which describe the assessments, strategies, and services the county office will use to help low-achieving students meet challenging academic standards.

The initial plan shall be submitted to the California Department of Education (CDE) and approved by the State Board of Education. Subsequent revisions of the plan shall be kept on file in the county office.

Comparability of Services

State and local funds used In schools receiving Title I funds, state and local funds shall be used to provide services that, taken as a whole, are at least comparable to services in schools that are not receiving Title I funds or, if all county office TCOE schools are receiving Title I funds, that are substantially comparable in each school. Comparability may be determined on a school-by-school basis or by grade span. (20 USC 6321)

To demonstrate comparability of services among county office TCOE schools, TCOE shall:

- 1. The county board of education shall Adopt and implement a county office TCOE-wide salary schedule.
- 2. Ensure equivalence in teachers, administrators, and other staff, as measured by either or both of the following:
 - a. The ratio of students to teachers, administrators, and other instructional staff at each Title I school within a grade span, which shall not exceed 110 percent of the average ratio across for all non-Title I TCOE schools within that grade span.
- 3. b. Salary expenditures for instructional staff at each Title I school, which shall be no less than 90 percent of the average salary expenditure across non-Title I TCOE schools.
- 3. All county office schools shall be provided with the same level of base funding per student for Ensure equivalence in the provision of curriculum materials and instructional materials supplies, by determining whether the per-student expenditure of state and local funds for curriculum materials and instruction supplies in Title I schools is between 90 and 110 percent of the TCOEwide average.
- 4. Determine whether the amount of state and local funds allocated per student for each grade span is between 90 to 110 percent of the per student average for each grade span in non Title I schools.
- 5. The county superintendent or designee shall maintain records of the quantity and quality of instructional materials and equipment at each school.

In determining comparability, the county office TCOE shall not include staff salary differentials for years of employment. The county office TCOE also may exclude unpredictable changes in student enrollment or personnel assignments that occur after the beginning of the school year, state and local funds expended for language instruction educational programs, state and local funds expended for the excess costs of providing services to disabled students with disabilities, and supplemental state or local funds expended in any school attendance area or school for programs that specifically meet the intent and purposes of Title I. (20 USC 6321)

At the beginning of each school year, The Tulare County Superintendent of Schools (county superintendent) or designee shall measure annually assess comparability in accordance with the above criteria and maintain records documenting the county office's TCOE's compliance. If any instances of noncomparability are identified, the county superintendent or designee shall promptly implement adjustments as needed to ensure comparability.

Program Evaluation

The county board of education shall use state assessment results and other available measures or indicators to annually determine whether each participating school is making adequate yearly progress toward ensuring that all students meet the state's proficient level of achievement on state assessments. (20 USC 6316) regularly monitor the progress of economically disadvantaged and low-achieving students in Title I schools. During the annual evaluation of TCOE's progress toward achieving each goal identified in the LCAP or other planning document addressing 20 USC 6312, the county board shall review disaggregated data on academic achievement, school attendance, and other outcomes for such students and shall ensure that strategies are revised as necessary to support continuous improvement.

The plan shall address the components specified in 20 USC 6312, which describe the assessments, strategies, and services the county office will use to help low-achieving students meet challenging academic standards.

The initial plan shall be submitted to the California Department of Education (CDE) and approved by the State Board of Education. Subsequent revisions of the plan shall be kept on file in the county office.

Comparability of Services

State and local funds used in schools receiving Title I funds shall provide services that, taken as a whole, are at least comparable to services in schools that are not receiving Title I funds or, if all county office schools are receiving Title I funds, that are substantially comparable in each school. Comparability may be determined on a school-by-school basis or by grade span. (20 USC 6321)

To demonstrate comparability of services among county office schools:

1. The county board of education shall adopt and implement a county office wide salary schedule.

2. The ratio of students to teachers, administrators, and other staff at each Title I school shall not exceed 110 percent of the average ratio across non-Title I schools.

3. Salary expenditures at each Title I school shall be no less than 90 percent of the average salary expenditure across non-Title I schools.

4. All county office schools shall be provided with the same level of base funding per student for curriculum and instructional materials.

5. The county superintendent or designee shall maintain records of the quantity and quality of instructional materials and equipment at each school.

In determining comparability, the county office shall not include staff salary differentials for years of employment. The county office also may exclude unpredictable changes in student enrollment or personnel assignments that occur after the beginning of the school year, state and local funds expended for language instruction educational programs, state and local funds expended for the excess costs of providing services to disabled students, and supplemental state or local funds expended in any school attendance area or school for programs that specifically meet the intent and purposes of Title I. (20 USC 6321)

At the beginning of each school year, the county superintendent or designee shall measure comparability in accordance with the above criteria and maintain records documenting the county office's compliance. If any instances of noncomparability are identified, the county superintendent or designee shall promptly implement adjustments as needed to ensure comparability.

Program Evaluation

The county board of education shall use state assessment results and other available measures or indicators to annually determine whether each participating school is making adequate yearly progress toward ensuring that all students meet the state's proficient level of achievement on state assessments. (20 USC 6316)







RESOLUTION OF EXCEPTION TO THE 180-DAY WAIT PERIOD

WHEREAS, in compliance with Government (Gov.) Code section 7522.56 of the Public Employee's Retirement Law, the Tulare County Board of Education must provide CalPERS this certification resolution when hiring a retiree before 180 days has passed since their retirement date; and

WHEREAS, Gregory Byerlee, CalPERS ID 3619078354 retired from the Visalia Police Department in the position of Police Sergeant effective 3/4/2023; and

WHEREAS, Gov. Code section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is September 1, 2023 without this certification resolution; and

WHEREAS, Gov. Code section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive; and

WHEREAS, the Tulare County Board of Education, the Tulare County Office Superintendent of Schools and Gregory Byerlee certify that Gregory Byerlee has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, the Tulare County Board of Education hereby appoints Gregory Byerlee as an extra help retired annuitant to perform the duties of Specialist – School Safety Program Training Services for the Tulare County Superintendent of Schools, Tulare County Office of Education ("TCOE") and the Tulare County Schools under Government Code section 21229 effective April 24, 2023; and

WHEREAS, no matters, issues, terms or conditions related to this employment and appointment have been or will be placed on a consent calendar, and

WHEREAS, the employment shall be limited to 960 hours per fiscal year for all CalPERS employers; and

WHEREAS, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

WHEREAS, the maximum base salary for this position is \$6182.71 and the hourly equivalent is \$35.68, and the minimum base salary for this position is \$5089.33 and the hourly equivalent is \$29.35.

WHEREAS, the hourly rate paid to Gregory Byerlee will be \$35.68; and

WHEREAS, Gregory Byerlee has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate; and

THEREFORE, BE IT RESOLVED THAT the Tulare County Board of Education hereby certifies the nature of the employment of Gregory Byerlee as described herein and detailed in the attached employment agreement/contract/appointment document and that this appointment is necessary to fill the critically needed position of Specialist – School Safety Program Training for the Tulare County Office of Education and Tulare County Schools by April 24, 2023 because:

1. This position is responsible for conducting safety trainings to school staff. Gregory Byerlee is a highly trained law enforcement retiree with expertise in the field of safety trainings. Given Gregory Byerlee's expertise, he would require minimal training to serve as a Specialist – School Safety Program Training Services. All schools will need to be trained appropriately and in a timely manner.

EMPLOYMENT AGREEMENT BETWEEN THE TULARE COUNTY SUPERINTENDENT OF SCHOOLS AND RETIREE GREGORY BYERLEE

This Employment Agreement ("Agreement") is made and entered into by the Tulare County Superintendent of Schools and the Tulare County Office of Education (collectively "County Superintendent") and Gregory Byerlee ("Retiree").

- 1. <u>Employment</u>. County Superintendent hereby employs Retiree, subject to all restrictions imposed by law, to perform work and as other work assigned by the County Superintendent.
- 2. <u>Term</u>. The term of this Agreement shall be from April 24, 2023 through August 31, 2023.
- 3. <u>Work</u>. Retiree agrees to perform duties as a Specialist School Safety Program Training and other duties as assigned by the County Superintendent or his designees.
- 4. <u>Compensation</u>. Retiree shall be paid compensation comparable to that paid to active employees performing comparable duties. In this case, Retiree shall be paid an hourly rate of \$35.68. Retiree agrees to submit to the County Superintendent a report of all hours worked each month and reasonably describe the work performed. County Superintendent agrees to pay Retiree for all work assigned and satisfactorily performed under the terms of this Agreement during the month after the work is performed. County Superintendent shall deduct from all monies owed Retiree all taxes and other deductions authorized by Retiree or required by law to be deducted. County Superintendent shall report all post-retirement employment earnings to CalPERS as required by law.
- 5. <u>Benefits</u>. Retiree shall not be entitled to any contribution toward any health and welfare benefits from the County Superintendent.
- 6. <u>Expense Reimbursement</u>. The County Superintendent shall reimburse Retiree for all actual and necessary expenses incurred by Retiree within the course and scope of performing work assigned under this Agreement. For reimbursement, Retiree shall submit and complete expense claims in writing in accordance with the County Superintendent's policies, rules and regulations and shall provide the County Superintendent with copies of his monthly expense reports. Expense claims shall be supported by appropriate documentation prior to reimbursement.
- 7. <u>CalPERS Post-Retirement Employment Notice</u>. The Retiree acknowledges that the Retiree is a CalPERS retired annuitant and is subject to post-retirement employment restrictions set forth in Government Code sections 7522.56, 21220.5, 21221, 21224, and other applicable provisions of law. The Retiree agrees that paragraphs (a) (b) and (c) below satisfy all notice requirements imposed by law. Retiree declares that prior to signing this Agreement, Retiree apprised himself of relevant data and received independent advice and counsel regarding the state and federal tax and retirement consequences of this Agreement.

- a. <u>Fiscal Hours Limitation</u>. The Retiree is subject to the annual fiscal hours limitation set by CalPERS, as that limit may change from time to time. For the 2022-2023 fiscal year the hours limit is set at Nine Hundred Sixty (960) hours. Retiree agrees he shall be solely responsible for monitoring the hours he works in order to ensure compliance with this limit. If the Retiree exceeds the annual fiscal hours work limit set by CalPERS, he shall be solely liable for any penalties or re-payments imposed by CalPERS on either the Retiree and/or the District as a result of exceeding this limit.
- b. <u>Retirement-Related Incentives</u>. The Retiree represents to the County Superintendent that he has not and will not receive a Golden Handshake or any other retirement-related incentive.
- c. <u>Unemployment Insurance Payment</u>. The Retiree represents to the County Superintendent that he did not receive any unemployment insurance payments in the preceding twelve months prior to the effective date of this Agreement.
- 8. <u>Tax/Retirement Liability</u>. Notwithstanding any other provision of this Agreement, County Superintendent shall not be liable for any retirement or state/federal tax consequences to Retiree, or any of her designed beneficiaries, heirs, administrators, executors, successors or assigns.

9. Termination of Agreement.

- a. <u>Mutual Consent</u>. This Agreement may be terminated at any time by mutual consent of the County Superintendent and Retiree.
- b. <u>Automatic Termination</u>. Unless extended in writing by the parties, this Agreement shall automatically terminate on the Expiration Date without further notice or action by either party. To the extent that notice of termination to either party is required by law, the parties agree that this provision satisfies all required legal notice provisions. This Agreement may also terminate prior to the Expiration Date if the Retiree exhausts the hours work limit imposed on CalPERS retirees during the applicable fiscal year.
- c. <u>Unilateral Termination by either Party</u>. Either party may unilaterally terminate this Agreement without cause or a hearing for any reason by giving the other party ten (10) calendar days advance written notice.

10. General Provisions.

- a. <u>Governing Law</u>. This Agreement, and the rights and obligations of the parties shall be construed and enforced in accordance with the laws of the State of California. Venue shall be in Tulare County, California.
- b. <u>Entire Agreement</u>. This Agreement contains the entire agreement and understanding between the parties. There are no oral understandings, terms or conditions, and neither party has relied upon any representation, express or implied, not contained in this Agreement.

- c. <u>No Assignment</u>. Retiree may not assign or transfer any rights granted or obligations assumed under this Agreement.
- d. <u>Modification</u>. This Agreement cannot be changed or supplemented orally. It may be modified or superseded only by a written instrument executed by both parties.
- e. <u>Exclusivity</u>. To the extent permitted by law, the parties intend and agree that the employment relationship between the County Superintendent and Retiree shall be governed exclusively by the provisions of this Agreement.
- f. <u>Construction</u>. This Agreement shall not be construed more strongly against either party regardless of which party is responsible for its preparation.
- g. <u>Independent Review</u>. Retiree has had the opportunity to obtain, and has obtained, independent legal or other professional advice with regard to this Agreement, and the consequences thereof, including tax and retirement consequences. Retiree acknowledges that the terms of this Agreement have been read and fully explained to her by her representative(s) and that those terms are fully understood and voluntarily accepted.
- h. <u>Execution of Other Documents</u>. The parties shall cooperate fully in the execution of any other documents and in the completion of any other acts that may be necessary or appropriate to give full force and effect to this Agreement.
- i. <u>Binding Effect</u>. This Agreement shall be for the benefit of and shall be binding upon all parties and their respective successors, heirs, and assigns.
- j. <u>Execution</u>. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Photographic copies of such signed counterparts may be used in lieu of the originals for any purpose.
- k. <u>Savings Clause</u>. If any provision of this Agreement or its application is held invalid, the invalidity shall not affect the other provisions or applications of the Agreement that can be given effect without the invalid provisions or applications and the provisions of this Agreement are declared to be severable.
- 1. <u>Public Record</u>. The parties recognize that, once final, this Agreement is a public record and must be made available to the public upon request.
- m. <u>Integration</u>. This Agreement constitutes a complete and exclusive statement of the understanding between the parties with respect to its subject matter. This Agreement supersedes any and all other prior communications between the parties, whether written or oral. Any prior agreements, promises, negotiations or representations related to the subject matter not expressly set forth in this Agreement are of no force and effect.

n. <u>Waiver</u>. Any waiver of any breach of any term or provision of this Agreement shall be in writing and shall not be construed to be a waiver of any other breach of this Agreement.
