## Pesticide Use

### HEALTHY SCHOOL ACT OF 2000 Pesticide Use

The Healthy Schools Act of 2000 was signed into law in September 2002, and required that all schools provide staff, parents or guardians of students with annual written notification of expected pesticide use on school sites. The notification will identify the active ingredient or ingredients in each pesticide product.

Staff, parents, or guardians may request prior notification of individual pesticide applications for the following Tulare County Office of Education departments/school sites (TCOE Administration Building, Doe Complex, Liberty Elementary, and University Preparatory High School). If you wish to receive a written notification at least 72 hours prior to any pesticide application, please download and complete the **Individual Pesticide Application Notification** form: [Parent Notification Form for Pesticides Link.docx](#)
