

She has also served as principal for La Joya Middle School and, most recently, as the Redwood High School principal.

Tulare Western High School students create visuals from CHOICES TUPE lessons

Recent lessons from the CHOICES
Programs' Tobacco-Use Prevention
Education (TUPE) has inspired Tulare
Western High School freshmen to create
visual representations of what they
learned. According to the California
Department of Education, the purpose
of the TUPE program is to reduce youth
tobacco use by helping young people
make healthful tobacco-related
decisions.

Over the course of seven lessons, CHOICES Specialist Jose Aispuro taught Tulare Western freshmen the dangers of vaping and smoking tobacco and cannabis. Students also learned how harmful chemicals such as nicotine can



hijack their brain chemistry and harm their bodies long-term, as well as other impacts that toxic chemicals can have on their lives and their environment.

In teacher Joseph Rivera's freshman studies class, students took it upon themselves to create a visual representation of how they could encourage people to avoid smoking and not risk falling into addiction.

"These students used their imaginations to translate what they learned during these lessons into creating posters to share facts and warn the public about the dangers of nicotine and cannabis," said Aispuro. "Their signs show unique illustrations that demonstrate the risks of where smoking can lead a teenager's life. Their incredible graphics and catchy phrases made me proud of our work as part of the CHOICES Programs. It was great to see these students engage and demonstrate their unique talents to exhibit their understanding of these topics."
