Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. Parents also have opportunities to plan and volunteer at school events such as the Fall Festival and the Walk-a-Thon. Currently 15% of the staff are parents.
