Job Title: Instructional Assistant, Arts Program (AcCEL) (9980)

# Job Summary:

The job of Instructional Assistant, Arts Program (AcCEL) is to direct learning experiences, maintain a suitable learning environment, prepare appropriate materials, maintain appropriate records, assist in the implementation of the IEP, and perform other related duties as assigned under the direction of a certified teacher.

#### **Essential Duties:**

- Assist teacher in providing instruction, assisting students, and delivering visual and performing arts lessons and activities.
- Prepare, set up, clean up, and assist in the use of arts program materials such as art supplies and musical instruments.
- Maintain and store instruments, art supplies, equipment, and other program materials in a clean and orderly
  manner.
- Conduct inventory of available instruments, art supplies, and other program materials and assist in ordering additional supplies, as needed.
- Assist teacher in implementing both the IEP and BIP, and developing and maintaining community services to provide safety in the classroom;
- Assist students to shape appropriate social behavior through positive reinforcement and prompt fading to provide increased independence in their social environment;
- Teach physical development, self-care, self-awareness; repositions and relocates students as needed to avoid self-injury and negative behaviors;
- Teach students individually and in small groups to reinforce instructional materials that improve self-care and to learn new skills and abilities while also reinforcing appropriate social behavior;
- Assist teachers with data collection and in choosing the most appropriate strategies to implement with each student:
- Monitor student activities, student behavior, and changes in behavior in order to maintain a positive learning environment and to provide feedback to parents and teachers;
- Assist with collecting data and maintaining records and files to document required and pertinent information;
- Administer first aid and medical assistance to provide appropriate care for the ill, medically fragile, and/or injured students;
- Participate in daily student activities, parent conferences, training sessions, and special activities to assist in the implementation and evaluation of student IEP and BIP objectives;
- Operate a variety of equipment (office, audio/visual, M.O.V.E.) and the school van to support the teacher in reinforcing classroom objectives;
- Dispose of waste contaminated materials, disinfects toys/equipment and classroom surfaces to maintain the hygiene and health of students and staff;
- Assume classroom responsibility by assisting substitute teachers in maintaining a safe and controlled classroom environment:
- Assist with laundry, general purchasing and running errands for the classroom;
- Perform other related duties as assigned to facilitate the smooth operation of the classroom/program.

# Skills:

- operate a variety of visual and performing arts and theatre equipment including, but not limited to, various musical instruments, drawing tools, art equipment, etc.;
- clean, organize, and maintain musical instruments and fine arts equipment in a safe and orderly condition;
- read notes, memos, and student reports of a moderately complex nature;
- · effectively interact with students, public, teachers and staff;
- organizationally determine steps in a process and structure time effectively;
- operate office, communication, audio visual, therapeutic, domestic, lifting, and handicapped equipment;
- assist in the maintenance of student files and retrieval of pertinent information;
- deal with disruptive or abusive behavior;
- implement proper feeding techniques (i.e. head and jaw control, midline positioning, etc.)
- recognize and follow procedures when seizures occur.

#### **Experience Required:**

- One year of paid or voluntary work with school aged children.
- Experience working with developmentally delayed or physically handicapped children preferred.

#### Other Requirements:

- Valid California driver's license and proof of automobile insurance.
- Department of Justice and FBI Fingerprint clearance upon hire.
- First aid and Cardiopulmonary Resuscitation Certificate (may be required).
- Ability to pass a general physical examination.
