Our grants seek to partner with TCOE programs, Tulare County school districts, schools, and educators seeking to improve our educational community and provide educational opportunities and innovative projects for students throughout Tulare County.


The Foundation offers grant programs – up to \$2,000 or up to \$5,000. The Foundation accepts grant applications throughout the year.

Completed grant applications including budget are reviewed by the Foundation Board monthly. All grant applications must be submitted to foundation@tcoe.org no later than first Thursday of each month for consideration and review during that month. Previously, awarded grant recipients are not eligible to apply again for two years from their approved grant award date.

Upon approval of your grant application, a grant award letter will be issued with the grant award amount and grant requirements. All grant recipients will be required to submit a final grant report and with project photos.

The Foundation does not intend to support other endowments, government entities, individuals (except scholarships), or organizations which are not directly connected to education in Tulare County.

The Tulare County Office of Education Foundation uses donations generated from the generosity of philanthropic individuals and organizations to fund the grant program.
